1. Data controller

2. Data we process

- Identification and contact details: first name, surname, email address and telephone number.
- Professional data: company or organisation, position and sector.
- Registration data and data relating to use of the event app (registration, interactions, agenda, networking).
- Where the event includes it, data necessary to manage travel and accommodation (travel and stay preferences).
- Where applicable: accessibility or dietary requirements - which may reveal health data and are processed only with your explicit consent -; image and voice if the event is recorded; and payment data if registration is paid.

Capture images and recordings during the event for dissemination.	Consent and legitimate interest (Art. 6.1.a/f).
Disclose your data to sponsors, partners and collaborating entities for their own commercial communications.	Consent (Art. 6.1.a).

Inform you about future editions and other events of the Controller.	Consent and legitimate interest / Art. 21 LSSI.
Comply with legal obligations (tax and accounting).	Legal obligation (Art. 6.1.c).

4. Recipients

- Processors providing services to the Controller: **Padcelona, S.L., Eventuris**, web hosting providers and, where applicable, payment gateway, pursuant to Art. 28 GDPR.
- Sponsors, partners and collaborating entities of the event: only if you have expressly consented, and only with respect to the authorised data and purposes.
- Travel and accommodation providers (agencies, hotels and transport companies) when necessary to manage your attendance at the event.
- Public administrations and bodies when there is a legal obligation.

5. Retention period

The data will be retained while the relationship and the purpose for which they were collected remain in place and, once ended, for the limitation periods of the applicable legal obligations. Data processed on the basis of consent will be retained until you withdraw it.

6. Rights

You may exercise your rights of access, rectification, erasure, objection, restriction of processing and portability, as well as withdraw the consent given at any time, by writing to the Controller at the addresses indicated in section 1, proving your identity.
